- \* Obtain any materials needed for class by the end of the first month. While the Academy has some equipment that students may use, it is the student's responsibility to equip themselves.
- \* Not teach the lessons I have learned to anyone else without express permission of John Lennox.

I understand the following:

- \* Any breach of the above Academy etiquette is cause for disciplinary action, up to and including dismissal from the Academy. No salle fee refunds will be given in cases of dismissal.
- \* If I fail to attend a class it is my responsibility to catch up on the lessons. I understand that instructors will make themselves available **by appointment** ½ hour prior to class session, for which I will not be charged extra, or I can schedule a private lesson with an instructor at their hourly rates.
- \* I will not receive a refund of salle fees for classes I miss.
- \* If the instructors of the salle must cancel class for any reason, the fees for that evening's class will be credited to my account.
- \* I can receive a 10% discount for paying for a minimum of 3 months in advance.
- \* I can receive a 10% discount each month for 6 months for every student I bring in who then signs up for classes.
